

Most of the residents of Woodland Cove are happy with the new blacktop on Wildwood Drive, connecting the Cove with Harvey Street. We are especially happy that it was done in such a manner that we still have the same winding, scenic drive down thru the woods, of which we are so proud, and without the removal of any of the trees.

It took years of negotiations with the Michigan State Highway Department at Lansing, the Cass County Read Commission and the Porter Township Board to accomplish this and we wish to thank the Cass County Engineers, the Porter Township Commissioners and the Porter Township Board for their interest, pasience and cooperation to accomplish this.

This project was done thru an agreement between The Woodland Cove Association and the Porter Township Foard who contracted with the Cass County Road Commission to do the grading, draining and blacktopping according to specifications and after conference with the State Highway Department, at a cost to the Woodland Cove Association of \$2190.00 which had to be paid before work was started.

However, we are disappointed and unhappy because a very few residents of The Cove have not paid their share or only a portion of their share. We are very grateful to the several parties who are neither members of The Woodland Cove Association nor residents of the Cove who contributed so generously. We hope that after driving down the new Wildwood Drive the others will feel oblighted to pay.

POLLUTION

Now that the lake season is drawing to a close, all Birch Lakers should ask themselves the following questions:

- 1. Have you checked your motor boat, power movers, cottage heating system, etc.? Are they working properly and not spewing out large amounts of unburned fuel?
- 2. Have you thrown all litter in bags or trash cans -- not into the lake or reads?
- 3. Have you been using detergents that are low in phosphates, or better yet, soap? Remember that in switching from detergents to soap, you must remove the detergent build-up or clothes will turn yellow. This can be done by washing clothes once in 4 tablespoons of washing soda; then wash in soap flakes or powder plus 2 to 4 tablespoons of washing soda.
- 4. Have you been saving old newspapers and magazines instead of burning them? The Salvation Army picks up old newspapers and magazines and the Packaging Corporation of America buys waste papers.
- 5. Have you avoided persistent and/or excessive use of pesticides and fertilizers?
- 6. Have you had your septic tank and water wells checked this summer?
- 7. Are you buying products that come in either re-usable or returnable packaging or bottles? The going rate is ½¢ per aluminum can for Sterling or Drewry's at Bremen Iron and Metal, 3113 South Gertrude Street; Hurwich Iron Company, 1610 Circle, South Bend; and South Bend Bailing and Iron at 1421 South Walnut. Helminen at 683-5499 in Niles can be called for pick-up.
- 8. Have you been enjoying outdoor recreation that does not require mechanization? Canoeing, hiking, walking, swimming, and sailing are activities that do not pollute—and they also help to take off unwanted inches!!!

Ideally, it would be nice if all Birch Lakers could answer yes to the above 8 questions. Realistically, let's <u>all</u> get to work and by next summer be able to score 100!!!

Mr. and Mrs. Clarence Needler of Lakeville, Indiana were luncheon guests of The Falmers on Wednesday.


The Valley Screen Process Company picnic was held at the Heckber's Cottage #302R in the Cove Saturday, August 15th. Fun was had by all.

EDITOR'S SOUND-OFF

NOW HEAR THIS !!! Cass County Sheriff, James Northrop, put out a mighty informative 25 page book entitled "Cass County County Sheriff's Safety Guide." Among the subjects included in the book are: Michigan's Implied Consent Law, Accident Reporting, School Bus Law, Michigan Marine Act of 1967, outline of gun laws in the matter of purchase, carrying and licensing of guns, both firearms and pellet and BB guns. Did you know that under Michigan Law on air pellet-pistol is considered a concealed weapon and subjects the person carrying it to the same penalty and license requirements as any other firearm? Sure—and the Editor didn't know it either!! Also, that a BB pistol

or hand gun can't be legally possessed or used outside the parent's property boundaries by anyone under 21 years of age unless the minor is accompanied by a person CVER 21 years of age?

Birch Lake has fortunately been almost free of problems relating to guns, with only an occasional youngster in a boat carrying a pellet or other air gun and it is likely that their parents did not know of this Michigan Law either. So perhaps this will be helpful.

Some time ago an article appeared, I believe in the National Rifleman magazine, reporting that trap and skeet shooting over ponds and lakes resulted in the lead shot-gun pellets which were distributed in the lakes producing a lead poisoning in water-fowls, ducks, geese, etc. and in some fish that picked up the shot in seeking food. Just another form, unexpected, of man-made pollution of water. Manufacturers are trying to find a substitute for lead in making shotgun pellets.

And a "thank you" to the Sheriff and his department for helping to reduce the "Ignorance of the Law..." which we all have (including lawyers and judges). Remember (from the book) the three "C's" --
