

The Fishing Club's motives are to improve fishing on Birch Lake, to see that laws and regulations concerning fishing are enforced, and to stimulate new fishing enthusiasts.

The Fishing Club had its first meeting last Saturday, July 31st, at the Yacht Club. The meeting mainly dealt with organizing the club. The following are notes taken from the meeting:

Fred Tbling reported on his trip to Plainwell, Michigan last fall, but he wasn't able to get a commitment to plant any fish in Birch Lake. Apparently, money is the reason. No bass were recently stocked anywhere in the state. Mr. Fbeling asked about placing Northern and Valleye in Birch and was told that this lake is not conducive to propagation for these fish. The members did report a small catch of smallmouth this year again.

The next topic of discussion was the netting of cisco. There is some thinking that the conservation department should supervise the cisco notters, in order to prevent taking game fish. The supervisor should make sure the stakes used are removed as they present a hazard to shiers. The conservation department will be asked for copies of the regulations applying to cisco netting. Puss Meaver will handle the contacts with the conservation officer.

The Club decided we get a cost from a private hatchery for planting approximately 5000 smallmouth bass (4" to 5" size). Mr.  $^{11}$ . R. Gardner will investigate the matter.

One member reported that he picked up about one bushel of beer and whiskey bottles (some broken) and beer cans on the ice about 150 feet from shore last January. Such a practice is extremely dangerous to swimmers, skiers, and all who use the lake.

The next meeting date is Saturday, August 21st at 2:00 p.m. at the Club House. The members hope to have a large turnout at the meetings so come and bring a friend.

Greetings from your friendly Marine Deputy. In this issue of the Birch Barker you will find some of the basic rules of safe boating and a few basic laws. If everyone would keep these and post them some place in the house so they can be seen by other members of the family and by any visitors you might have, it would help keep Birch Lake the safe place it is.

Recently there have been several larcenies of boats, motors, boating equipment, and fishing tackle in the county. These have been taking place at various times during the summer, but the last two weeks of July activity of this sort picked up. To date there have been 10 boats and 17 motors stolen. As of now Birch Lake is not on the list of lakes that has been hit. But this is not saying that it won't be. The only way to be sure that you won't have anything stolen is to not leave it in your boat overnight. Fire extinguishers, boat cushions, and fishing tackle are often left in the boat overnight and are very easy to take. All of the motors that have been stolen have been small fishing motors, 10 HP or less. Most of these have been locked on the boat, but bolt cutters were used to cut the locks.

Just recently there was an explosion on Diamond Lake of an inboard. Eight people were BLO'N out of the boat and into the water. Fortunately they were close to shore and in shallow water. No one was seriously injured, which is a miracle in itself. The only reason there was not a fire resulting from the explosion is there was a fire extinguisher on board and several others nearby that were used. This proves that fire extinguishers are a necessary part of your safe boating equipment.

Parents are again reminded that mini-bikes are not to be driven on county roads if they are not licensed or the operator is not licensed.

### \* \* \* \* \* \* EDITOR'S SCUND-CFF

ALL boat operators—whether they are residents on the lake, visitors, renters or guests—are subject to the same marine laws, rules and regulations SO—in travel around the lake go counter—clockwise. SO—don't go behind rafts or floats when swimmers are out. Drop your skiers OUTSIDE and not INSIDE swimming areas. SO—if you are swimming outside floats or rafts watch your step (or strokes)—boats have a legal right to be in the lake too and a big prop can shred you up nicely. A word to parents too—your kids floating and swimming outside swim areas aren't

to be in the lake too and a big prop can shred
you up nicely. A word to parents too- your kids
floating and swimming cutside swim areas aren't
"prop-proof" either. So far, we have been lucky at Birch Lake but
there's always a First Time and you wouldn't want it to be Your Youngster, would you?? SO--if you Scuba or Snorkel, use a flag, warning
craft, etc. SO--its about time that property owners, their renters,
guests, and all lake visitors get the idea that Birch Lake is for
USE - NOT ABUSE and that property rights are still in existence and
can and will be enforced. As illustrated in a recent issue of the
Barker the riparian rights of the owners of lake property includes the
exclusive right to moor his boat, to personally limit the use of his
pier, raft, or float to those to whom he gives permission where the
pier, raft, or float is located in front of the owner's lot. In other
words, your pier, float, boat, etc. "ain't public property and there
is NO EASEMENT FOR PUBLIC USE ALONG THE SHORELINE OF THE LAKE either.
Being a "Liberal" gives no license to use the other guy's property
unless he consents and it is advisable to get that consent first.

Recently a boat operator has been doing his/her level best to get attention from the Sheriff's Dept by running behind floats and rafts and in swimming areas when swimmers were out and two or three observers are ready and willing to see that he/she gets that attention and/or a trip to the local "clink". Cur Marine Deputy is courteous, cooperative and friendly --but--this does not mean that "wise guys" can get by indefinitely.

SUGGESTION --- That Marine Rules and Regulations in force at Birch Lake be posted at the public beach to inform and warn boat owners bringing in their craft relative to use on the lake. This will nullify the excuse "I did'nt know about any such regulation" which is always a convenient alibi --particularly for visitors and renters.

# CASS COUNTY SHERIFF'S DEPARTMENT RULES AND REGULATIONS FOR OPERATION OF VATERCRAFT ON ALL STATE CONTROLLED VATERVAYS

- 1. All watercraft with motors must be registered and registration numbers affixed to watercraft.
- 2. No person shall operate any watercraft while under the influence of alcoholic beverage or narcotic drug, nor shall the operator consume any alcoholic beverage while in the process of operating any watercraft.
- 3. Any person who operates any watercraft in a careless and heedless manner so as to disregard the rights or safety of others, and at a speed that would endanger or likely to endanger any person or property shall be guilty of reckless operation.
- 4. Po person shall operate any watercraft at a speed greater than will permit him to exercise of reasonable care, to bring the water-c craft to a stop within the assured clear distance ahead.
- 5. No person shall operate a watercraft in a manner so as to unreasonably interfere with the lawful use by others of any waters.
- 6. All motor boats must operate in a counterclockwise direction.
- 7. No operator of any watercraft shall have in tow any person on water skis, watersled, surfboard, or any similar contrivance during the period 1 hour after sunset to 1 hour prior to sunrise.
- 8. All accidents resulting in personal injury or property damage to exceed 100 dollars shall be reported to local law authorities. (Sheriff's Department in this area).
- 9. There must be : competent observer plus the driver in any water-craft towing water skis, or any similar contrivance and the boat must be equipped with a 170° mirror.
- 10. All persons must be seated in the seats provided when the water-craft is underway or in motion; sitting on the decks or gunwale is prohibited.
- 11. No operator shall allow his watercraft to pass closer than one hundred (100) feet to any fishing craft.
- 12. No operator shall allow his watercraft to pass closer than one hundred (100) feet from any swimming area except when docking or debarking.
- 13. No person being towed on water skis or other similar contrivance shall be closer than one hundred (100) feet to any swimming area, fishing craft, pier, raft, or another watercraft.
- 14. The only exception to regulation above is when landing and taking off then, extreme caution must be used.
- 15. Running lights are required on all watercraft between sunset and sunrise. (Red and Green front; white on rear).
- 16. Any organized and properly supervised race (authority from State 'aterways Commission) has the right-of-way over waters designated as raceway during the period of the race.
